7. Assessment

Assessment will be based on a written examination of 2-hour (for a semester module) or 3-hour (for a yearly module) duration as specified and continuous assessment carrying a range of 20% to 30% of total marks except for Module Research Methods in Law and Management. Continuous assessment will be based on two (2) assignments and should include at least one class test per module per year.

For a student to pass a module, an overall total of 40% for combined continuous assessment and written examination components would be required without minimum thresholds within the individual continuous assessment and written examination.

Written Examination and Continuous Assessment would each carry a weighting of 50% each for the **Module Research Methods in Law and Management (LAWS 2235Y(3)).** Continuous Assessment would be based on writing literature review, developing research methodology and research proposal/report writing.

Dissertation is compulsory and will carry 6 credits.
