

DUTIES:

EXPRESSION OF INTEREST

The University of Mauritius, as an equal opportunity employer, is inviting applications from suitably qualified candidates to signify their interest for enlistment as **Occupational Health Physicians.**

QUALIFICATIONS: Candidates should:

- **A.** Possess a postgraduate qualification in the field of Occupational Health from a recognised institution or an equivalent qualification acceptable to the University of Mauritius.
- **B.** Be fully registered as Medical Practitioners in accordance with legislation in force in Mauritius and should possess a Business Registration Number, which should be provided to the University of Mauritius, in case the candidates are selected.

<u>Note:</u>

- (i) Candidates should submit a copy of their Certificate of Registration as Medical Practitioners in Mauritius together with their applications.
- (ii) Candidates should also provide written evidence of knowledge and experience claimed.
- 1. To provide advice in the field of Occupational Health with a view to promoting and maintaining the highest level of health of workers at the University.
 - 2. To conduct epidemiological and other health surveys among workers, as and when required.
 - 3. To carry out clinical examinations and biological monitoring among workers engaged in hazardous occupation, as and when required.
 - 4. To identify work-related disease at the earliest point and facilitate early intervention and treatment.
 - 5. To evaluate occupational hazards at work and submit reports on same, if required.
 - 6. To provide Health Surveillance Report as per Section 77 of OSHA 2005.
 - 7. To deliver health education talks to employees and to advise on preventing/minimising work-related illness.
 - 8. To attend to complaints made by representatives of employees and employers.

9. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Occupational Health Physicians in the roles ascribed to them.

<u>REMUNERATION:</u> Candidates will be remunerated as follows:

- Rs1000/-, per hour of work.
- Rs1500/-, for conducting talks and training.
- Rs2000/-, per sitting at the Medical Board.

CONDITION: The duration of the contract will be for an initial period of **one (1) year on a part-time basis**, as and when required.
