SCHEME OF SERVICE FOR THE POST OF LECTURER

Prescribed Qualifications

: A Degree and a Master's Degree in the relevant field from a recognised institution.

For recruitment of Lecturers in the field of Medicine, candidates may be required to hold a MBBS or MBChB, be a registered medical practitioner and reckon at least four years relevant post qualification work experience.

In scarcity areas or in cases where the University faces difficulties to recruit Lecturers, Management may consider the recruitment of candidates possessing a **Honours Degree in the specified field along with at least five years post qualification work experience.**

Reporting Line

: Dean of Faculty through Head of Department

Duties

- Teaching, Research, Administration, Consultancy Activities, Examination and Invigilation.
- Designing programmes of studies, preparing lecture notes, teaching materials, teaching aids and distance education on-line courses.
- Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them.
