# MA PUBLIC POLICY (F/T) – SH545

## 1. Objectives

The full time MA Programme offers a comprehensive understanding public policy processes at different stages. This will encompass methods for formulating and selecting policies, programmes and expenditures and application of new and conventional theories and principles for improving public sector governance and service delivery. Moreover, this Programme fits well within the context of a global and market oriented economy and addresses the challenges that public policy making must address.

At the end of the programme students should be able to demonstrate a thorough intellectual grounding and practical experience in the processes of policy making, as well as an understanding of the range of knowledge and skills they need to be effective in the world of policy.

## 6. Credits per Year

#### 7. Assessment

Each module will carry 100 marks and will be assessed as follows (unless otherwise specified): written examination of 3-hours duration for modules with 6 credits and 2 hours duration for modules with 3 credits. Continuous assessment will count for 30% to 40% and can be based on seminars and/or assignments. Modules accounting for 3 credits should include at least 1 class test and modules with 6 credits, at least 2 class tests.

Written examinations for all modules will be carried out at the end of the Semester in which they are taught (unless stated otherwise).

An overall total of 40% for combined continuous assessment and written examination components would be required to pass a module, without minimum thresholds within the individual continuous assessment and written examination. The same criterion will apply for modules being assessed jointly. Note that all overall mark for the two modules will be considered and not the individual marks for each of the two modules.
