7. Assessment

Each module will carry 100 marks and will be assessed as follows:

Assessment will be based on a written examination of 2-hour (for a semester module) or 3-hour (for a yearly module) duration as specified and continuous assessment carrying a range of 20% to 30% of total marks except for module Research Methods in Law and Management. Continuous assessment will be based on two (2) assignments and should include at least one class test.

For a student to pass a module, an overall total of 40% for combined continuous assessment and written examination components would be required without minimum thresholds within the individual continuous assessment and written examination.

Written Examination and Continuous Assessment would each carry a weighting of 50% each for the **Module Research Methods in Law and Management (LAWS 2235Y(3)).** Continuous Assessment would be based on writing literature review, developing research methodology and research proposal/report writing.

Dissertation is compulsory and it will carry 6 credits.
